- All your providers should honor your appointments
- You can change your physical health plan or your dental plan by calling CareOregon Customer services.
- CareOregon provides Mental Health and Substance use treatment services for all Health Share members, no matter which physical plan you are assigned to.
- Careoregon advantage members (Medicaid/Medicare) have no change in their coverage and should continue seeing their same providers.
