Leadership Introduction - What's Going on at CareOregon

Amy Dowd, Chief Operations Officer, joined meeting to share what's going on at CareOregon. Deep appreciate of this Board and making sure that we're advocating for our members and their unique health needs. Access to care for members is not only for critical care needs but their preventive care needs. Thank you all for your dedication and interest!

Amy recognized Anna for filling in on the transition for Tamara. Anna has brought this group together and is providing great leadership and momentum. Welcome to the new team members – Linda, Erica and Caroline.

CareOregon is embarking on our new journey with our affiliation with Providence. CareOregon will maintain our secular position and our services will not change at all. The CareOregon name, brand, Board of Directors will remain the same. Providence is looking to CareOregon to be their Medicaid leader/provider. This affiliation will bring more access to capital for CareOregon so that we can expand further in Oregon or even out of the state. Centene (Trillium Health Plan) has come into the area so there will be another option in the Metro area for Medicaid. For our Duals line of business, Providence has a 4 ½ star rating, so we will lean on that star rating to perform better for those members.

Why Providence? CareOregon and Providence align with missions and wanting to serve the underserved. With this affiliation, there is an ability for CareOregon to influence Providence. Providence is also a non-profit.

Does Providence have a Member Service Advisory Board and would they have a place at this Board? Amy will talk to Providence on this item and follow up with Anna.

Currently CareOregon and Providence are examining what we do well/what they do well/what we could both adopt to do better. CareOregon will be getting our voice out officially with an op-ed in the next couple weeks. Goal is to have a definitive agreement sometime in 2020.
